    - You must still complete the poster project and turn in at mini judging on July 13 to show a horse.
    - There is a waiver/form that must be turned in with the poster in order to show. See the extension office with questions.
- Rules Review:
  - 26. All classes shall be conducted and judged according to the current Official Handbook of the Indiana 4-H Horse & Pony Program. (Available to members

- online or the Extension Office.)
- 27. Each class shall be judged and placed according to the judge's discretion.
  Decision of the judges will be final. Refer to General Rule #16 of the Johnson Co.
  4-H Handbook for Protest Procedure.
- o 28. Riding of all animals is restricted to DESIGNATED AREAS.
- 29. The 4-H animal may only be ridden or driven by the 4-H member who enrolled the horse, during a 4-H event or function.
- 30. Riders with gaming horses, riders with pleasure horses, and driving horses with carts will not share the show ring at the same time.
